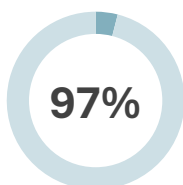

## PATENT PROSECUTION

Assisting **Columbia University** with strategic patent advice and the worldwide prosecution of about 2,300 patent applications for the Morningside and Medical Center campuses. We prosecute applications in a wide variety of high-tech, medical device and pharmaceutical areas, including small molecule and biologic therapies to treat an extensive spectrum of medical conditions.

## POST GRANT PROCEEDINGS

Achieved a significant victory on behalf of client **PNC Bank N.A.** when the PTAB invalidated all challenged claims in three mobile-banking patents owned by United Services Automobile Association, including all asserted claims in one of USAA's patents behind a recent \$218.5 million jury verdict of infringement against PNC's mobile banking app.

Achieved a victory for **Intel** when the Federal Circuit reversed the PTAB's decision and held that all challenged claims of US Patent No. 9,154,356 were unpatentable for obviousness. The patent was part of a multi-year battle between Intel and Qualcomm, with Qualcomm initially accusing Apple of infringing the patent through the sale of smartphones containing Intel chips and seeking to bar the import of Intel-based iPhones.

## TRADEMARK, TRADE SECRET AND COPYRIGHT PROTECTION

Our team was named *Litigation Daily's* "Litigators of the Week" in recognition of a trademark victory for **T-Mobile** in its high-stakes dispute with Simply Wireless in which T-Mobile was awarded summary judgment against Simply Wireless's claims that T-Mobile's use of the "Simply Prepaid" name infringed on its common law ownership of the phrase.

Secured major victory for **Reckitt Benckiser** following a jury trial in the District of New Jersey when claims brought by Absorption Pharmaceuticals, which sought \$454 million in damages for alleged fraud and trade secret misappropriation, were rejected.
